Amendment of Section B, II, B, 2 of Supplemental Instructions for Administration of Title VI of the Civil Rights Act of 1964, dated July 2, 1965, states:

"Each State Extension Director shall be responsible for determining that Extension personnel assist or conduct programs only through those private organizations that do not discriminate on the basis of race, color or national origin with respect to participation in and benefits from activities of the organization. Written notification of this Extension policy must be made to appropriate officials of private organizations with which Extension workers maintain continuing assistance or continuing cooperative relationships in conducting Extension programs. This notification should make it clear that Cooperative Extension cannot provide assistance to any organization that excludes any person from membership or participation in any activities of the organization, or subjects any person to discrimination because of race, color, religion, sex, national origin, age, disability, veteran status, or sexual orientation."

Title IX of the Education Amendments of 1972 provide that no person on the basis of sex be excluded from participation or be denied the benefits of, or be subject to discrimination under any educational program.

The University of Arizona Cooperative Extension complies with Titles VI and IX of the Civil Rights Act, appropriate amendments, and Section 504 of the Rehabilitation Act.

Section 504 of the Rehabilitation Act of 1973, as amended, provides:

"No otherwise qualified disabled individual in the United States, as defined in section 7(6), shall, solely by reason of their disability be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance."
